### 1. Basic Philosophy & Aims and Admission Policy

The basic philosophy of the Master's Course of the Graduate School of Health Sciences is to establish an academic system of health sciences through comprehensive and cutting-edge education and research in the fields of health, medicine, and welfare, and to contribute to the development of the health and welfare of the people by giving back to society the results of such research. Its departments also aim to foster highly specialized professionals and educators/researchers who possess a rich humanity based on a high ethical standard centered on human dignity, advanced professional knowledge, and the ability to exercise leadership in the field of medicine.

In light of the above, the Master's Course seeks individuals:

- ① who have enthusiasm to contribute to the health needs of the nation.
- ② who have the basic academic abilities to receive education in health sciences.
- ③ who have a strong desire to pursue health studies and be proactive in their studies and self-development.
- ④ who aim to become practical leaders (advanced professionals) or educators/researchers in the field of health, medical care, and welfare.
- ⑤ who are willing to contribute to the local community in the areas of their expertise as well as to think and play active roles from a global perspective.

### 3. Obtainable Qualifications

#### Nursing Course

- (1) If students fulfill the necessary requirements, they may become public health nurses, midwives, or teachers in nurse training schools.
- (2) In accordance with the accreditation of the program for the Senior High School Teacher's License (Nursing) based on the Education Personnel License Law, those who have obtained a Class 1 License (Nursing) can obtain a Senior High School Teacher's License (Nursing) if they acquire the necessary credits.

#### Radiological Sciences Course

Students will be eligible to take the Medical Physicist Certification Examination.

#### Genetic Counseling

If students fulfill the necessary requirements, they will be eligible to take the Certified Genetic Counselor Certification Examination.

## 4. Eligibility for Application

### General Entrance Examination

Applicants are those who fit into any of the following cases:

- (1) Persons who have graduated from a university or who are expected to graduate from a university by March 2025.
- (2) Persons who have received a bachelor's degree, or who are expected to receive a bachelor's degree by March 2025.
- (3) Persons who have completed 16 years of school education in a foreign country, or who are expected to complete the said school education by March 2025.
- (4) Persons who have completed, or are expected to complete by March 2025, 16 years of school education of a foreign country by completing a correspondence course conducted by a school in the said country while residing in Japan.
- (5) Persons who have completed, or are expected to complete by March 2025, a foreign university's course of study at an educational institution in Japan that is positioned in the school education system of a foreign country as having a university course whose graduates are recognized as having completed 16 years of school education in the relevant foreign country, and that is designated by the Minister of Education, Culture, Sports, Science and Technology of Japan as having such a course.
- (6) Persons who have received a degree equivalent to a bachelor's degree by completing a 3-year or longer course of study at a university or other school\*<sup>1</sup> in a foreign country\*<sup>2</sup>, or who are expected to receive the said degree by March 2025.

\*<sup>1</sup> These schools are limited to those that have been evaluated by a person accredited by the government or a relevant organization of the foreign country with regard to the overall status of their education and research activities, etc., or those that are designated by the Minister of Education, Culture, Sports, Science and Technology of Japan as having been equivalently evaluated.

\*<sup>2</sup> Including completion of a course of study in Japan by taking a correspondence course offered by a school in a foreign country and completion of a course of study at an educational institution designated in the school education system of a foreign country as set forth in the preceding item.

- (7) Persons who have completed, after the date specified by the Minister of Education, Sports, Science and Technology of Japan, a special training course of a vocational school (limited to those that meet the criteria specified by the said Minister, including the study term of four years or longer) designated separately by the Minister, or who are expected to complete the said special training course by March 2025.
- (8) Persons who have been designated by the Minister of Education, Culture, Sports, Science and Technology of Japan (Under Notification No. 5 of the Ministry of Education, 1953).
- (9) Persons who have been enrolled in other graduate schools and have been approved as having sufficient scholastic ability to receive graduate school education in the Graduate School of Health Sciences, Kumamoto University (in accordance with the stipulation in Article 102, paragraph 2 of the School Education Law).
- (10) Persons who are recognized by the Graduate School of Health Sciences as having scholastic ability equivalent or superior to that of a university graduate as a result of individual screening of the Eligibility for Application, and will reach 22 years of age by March 2025. [See Note 1 and Note 2 below.]
- (11) Persons who have been enrolled in a university for at least three years and who are recognized as having earned credits designated by Kumamoto University with excellent grades. [See Note 1 below.]
- (12) Persons who have completed 15 years of school education in a foreign country, or while residing in Japan by studying through correspondence courses conducted by the said country, and are recognized as having earned credits designated by Kumamoto University with excellent grades. [See Note 1 below.]

### International Student Entrance Examination

Applicants are those who do not have Japanese nationality and meet any of the eligibility categories (1) to (12) for General Entrance Examination above.

Note 1: Both for General Entrance Examination and International Student Entrance Examination, applicants with one of the eligibility categories (9) to (12) above will need a screening of the eligibility for application. Please see "5. Screening of Eligibility for Application" on page 2 for details and apply for the screening in advance.

Note 2: Applicants with the eligibility category (10) above are graduates of junior colleges, technical colleges, vocational schools and other schools, as well as graduates of Japanese branches of foreign universities, schools for foreign nationals, and other educational institutions, who do not have a university diploma, but who are recognized by the Graduate School of Health

Sciences as having scholastic ability equivalent or superior to a university graduate as a result of individual screening of their abilities. The criteria for the academic record and research/working period (years of experience) are indicated in the table on page 3.

## 5. Screening of Eligibility for Application

### (1) Period of submission of the application documents

Applicants with one of the Eligibility for Application categories (9) to (12) above will be screened for their eligibility for application in advance. Please submit the documents listed in (3) below.

Period of submission: from October 28 (Mon) to October 31 (Thu), 2024.

If mailing the documents, send a set of the documents enclosed in an envelope by registered express mail with the words, “2<sup>nd</sup> Term Application Documents for Screening of Eligibility for Application to Master’s Course, Graduate School of Health Sciences, Kumamoto University enclosed” clearly written in red on the front of the envelope.

### (4) Screening of Eligibility for Application

The screening of eligibility for application will be based on the number of years applicants have been enrolled in universities or other educational institutions, the number of credits earned, and so on stated in the application documents.

### (5) Result of Screening of Eligibility for Application

The result of the screening will be mailed to the applicant. Applicants who have passed the screening should immediately prepare the documents required for the application for the entrance examination as stipulated in “11. Application Materials to Submit” on page 5 and submit them within the application period.

### (6) The criteria regarding academic record, research/working period (years of experience), etc. for the screening of the Eligibility for Application category (10) are as follows:

Academic record of your most recent educational institution	Research/working period (years of experience) after the most recent academic record
① Graduates of a junior college that requires two years for graduation	At least two years
② Graduates of a junior college that requires three years for graduation	At least one year
③ Graduates of a technical college	At least two years

④ Graduates of a special training course of a vocational school that requires two or more years for graduation	The period calculated by deducting the years required for graduation from the vocational school with a special training course, from the years required for graduation from a university (four years), or longer
⑤ Persons who have graduated from or completed a Japanese branch of a foreign university, a school for foreign nationals, a vocational school (excluding its special training course), and other schools, as well as other educational institutions in Japan and overseas	The period calculated by deducting the minimum years of education required until the graduation from/completion of the most recent educational institution, from the minimum years of education required until graduation from a university (16 years), or longer
⑥ Dropouts of the educational institutions described in ① to ⑤ above	The period calculated by deducting the years of education until the dropout from the relevant educational institution, from the minimum years of education required until graduation from a university (16 years), or longer

Note: The research/working period (years of experience) refers to the combined total periods below.

- (a) Period of enrollment in a university or a college as a research student
- (b) Period of enrollment in a major course of a junior college or a technical college
- (c) Period of employment as an educator/researcher in an educational/research department of a university, junior college, government/municipal agency, research institute, company, etc.
- (d) Period of engaging in healthcare work (as a nurse, midwife, public health nurse, medical radiology technician, clinical technologist, etc.)
- (e) Period of being in a situation similar to (a) to (d) above

## 6. Screening Method

- (1) Applicants will be screened based on a comprehensive assessment of their written examination, oral examination, and application documents.
- (2) Date/time, subjects, and venue of scholastic ability examinations

Depending on the number of examinees, the examination start time may be changed. Meeting time will be announced when the examination voucher is sent.

### Important Notes

- ① On the day of the examination, examinees must arrive at the venue (Graduate School of Health Sciences, Kumamoto University) at least 30 minutes before the start of the examination.
- ② Only the use of a book-type English-Japanese dictionary is permitted in the written examination. Any electronic devices functioning as a dictionary are not permitted.
- ③ Latecomers for the examination due to unavoidable circumstances will be allowed to take the examination only if it is within 30 minutes from the start of the examination.
- ④ Examinees are not allowed to leave the examination room before the examination ends.
- ⑤ The results of any examinee who has committed a dishonest act during examination will be invalid. Once the act is discovered, he/she is not allowed to continue to take the examination any longer.
- ⑥ Examinees must turn off their mobile phones.
- ⑦ Only the following items are permitted to be placed on the desk: The Admission Ticket, an English-Japanese dictionary, (permitted) writing utensils, watches, erasers and pencil sharpeners.

## 8. Pass/fail Criteria

- (1) Successful applicants will be selected in the order of highest total score.
- (2) In the case of a tie, the priority will be given to the applicants with the higher score in the oral examination.
- (3) Applicants who score less than 60% on either the written or oral examination will fail.

## 9. Prior Consultation

Those who wish to apply for the entrance examination must have a prior consultation, regarding their future master's research, with the faculty member from whom they wish to receive academic guidance. Please see "Full-time Supervisors and Research Themes" for the faculty members. For prior consultation, please contact the faculty member by e-mail.

If working adult applicants wish to apply for the special arrangements for school hours, they should ask about the matter at the time of prior consultation.

Period of Prior Consultation: **October 11 (Fri) to October 18 (Fri), 2024**

## 10. Application Period

**November 12 (Tue) to November 18 (Mon), 2024 (No later than 5 p.m. JST)**

Only documents postmarked on or before November 16 (two days before the deadline) will be accepted if arrived after the application period.

Please send a set of your application documents enclosed in an envelope **by express registered mail** with the words, "2<sup>nd</sup> Term **Application documents for Entrance Examination for Master's Course, Graduate School of Health Sciences enclosed**" clearly written **in red** on the front of the envelope. The application documents will not be accepted if brought directly to us. Be sure to send them by mail.

## 11. Application Materials to Submit

1	Admission Application Card	[Designated form] Refer to "How to Fill out the Admission Application Card".
2	Photo Card, Admission Ticket, Address Card	[Designated form] Attach a photo (4 cm × 3 cm) of frontal portrait with no hat taken within three months before application on the "Photo Card" and "Admission Ticket" for each.
3	Academic Transcript	The transcript must be an original, issued in the name of the president (dean) or principal of the university (department) or any other educational institution from which the applicant graduated, and strictly sealed.
4	Certificate of (expected) Graduation	The certificate must be an original, issued in the name of the president (dean) or principal of the university (department) or any other educational institution from which the applicant graduated (is expected to graduate).

5	Certificate of (expected) bachelor's degree	<b>For applicants who meet the Eligibility of Application category (6)</b> The certificate must be an original, issued by the head of the university/school. The applicant also needs to submit a certificate of the result of the evaluation of the university/school <sup>(*)</sup> , of which the applicant has received (is expected to receive) the degree, issued by the evaluation organization or the head of the university/school. This certificate must also be an original.

If applicants cannot submit a certificate of evaluation for the universities/schools by any of the organization above, they must apply with eligibility of application category other than (6). In that case, applicants may need a screening for application eligibility.

#### Important Notes

1. Applicants with the Eligibility for Application category (2) should submit a certificate of bachelor's degree conferment or a certificate of acceptance of bachelor's degree conferment application issued by the National Institution for Academic Degrees and Quality Enhancement of Higher Education.
2. **Application documents (except for "Reason for Application & Desired Research Form") written in English must be submitted along with their Japanese translations.**
3. If your current name and your name on the certificates are different due to a change of your family name or other reason, please submit an extract from your family register along with the certificates.
4. If you make any false statement in your applications, your admission may be revoked.

## 12. How to Pay the Entrance Examination Fee

(1) Examination fee: 30,000 yen

(2) Payment period: **November 7 (Thu) to November 18 (Mon), 2024**

(3) Where to pay: At the reception counter of a post office or bank

Bank transfer fees shall be borne by the applicant.

Do not use an ATM (automated-teller machine) for the payment. Be sure to pay at the reception counter of a post office or bank.

(4) How to pay

①[For applicants who reside in Japan]

Please pay the examination fee at the reception counter of a post office or bank after filling out the examination fee payment form. Do not use an ATM (automated-teller machine) for the payment.

After the payment, be sure to attach the "Certificate of Payment" issued at the reception counter to the "Sheet for Examination Fee Payment Certificate" and submit the Sheet.

②[For applicants from abroad]

Bank transfer fees shall be borne by the applicant.



### (5) Important notes regarding application

- ① Application will not be accepted, if the examination fee has not been paid, or if the “Certificate of Payment” is not attached to the designated place of the “Sheet for Examination Fee Payment Certificate.”
- ② Once the application documents are received, the examination fee will not be refunded except for the following cases:
  - 1) The applicant has paid the examination fee, but the application has not been made (either the application documents have not been submitted or they have not been accepted by the university), or
  - 2) The applicant has paid the examination fee more than once by mistake.
- ③ Bank transfer fees for refunding shall be borne by the applicant.

#### How to request for a refund of the examination fee

Prepare a “Request for a refund of the examination fee” (any format is acceptable), which clearly shows the reason for the request, applicant’s name (with name seal on the right of applicant’s name), name of Graduate School the applicant has applied for, applicant’s current address, postal code, contact phone number, name of the bank to be used for transfer, branch name, account number of an ordinary deposit and accountholder’s name (with the name in English). If the applicant’s name and accountholder’s name are different, the relationship between the applicant and the accountholder must be also indicated. Then, send it with the “Certificate of Payment” attached to the “Sheet for Examination Fee Payment Certificate” by mail immediately.

Applications will be accepted until March 31, 2025. The paid examination fee will be refunded after the month following the date of receipt of the request.

## 13. Announcement of Successful Applicants

### **December 18 (Wed), 2024**

Notification of acceptance will be mailed directly to successful applicants.

In addition, the examination ID numbers of successful applicants will be announced on the website of Kumamoto University at around 11:00 a.m. on the announcement day. (The announcement on the website may delay depending on the communication environment on that day.)

## 14. Enrollment Procedure

### (1) Enrollment procedure

Details of the enrollment procedure will be provided with the notification of acceptance.

Enrollment procedure should be completed online.

Required expenses at the time of enrollment

Entrance fee: 282,000 yen (expected amount)

Those who do not complete the enrollment procedure during the designated period will be considered to have declined admission to the Graduate School of Health Sciences.

### (2) Tuition

Per each first and second semester: 267,900 yen (annual amount: 535,800 yen) (expected amount)

Note: If the amount of tuition is revised, the new amount will apply from the time of revision.

- (3) Exemption system for affected households in areas covered by the Disaster Relief Act  
For students whose financial providers live in areas covered by the Disaster Relief Act and who have difficulty paying the entrance and tuition fees due to a disaster to which the Disaster Relief Act applies, payment of the full or half amount of the entrance and tuition fees may be exempted if approved upon the student's application and screening process. (In the case of a half-tuition fee exemption, the payment of the entrance fee will be postponed for a certain period if approved.)

Note: The application covers entrance and tuition fees to be paid within one year of the occurrence of the disaster.

## **15. Scholarships**

[For Japanese students]

Students can apply for the scholarship of the Japan Student Services Organization for the First-class Scholarship (choices are from the monthly loan of 50,000 yen or 88,000 yen) or the Second-class Scholarship (choices are from the monthly loan of 50,000 yen, 80,000 yen, 100,000 yen, 130,000 or 150,000 yen depending on the screening result). Other scholarships from local governments and private organizations may also be available.

## **16. Entrance Fee Exemption/Postponement and Tuition Fee Exemption**

Those who meet the qualifications for entrance fee exemption/postponement and tuition fee exemption, if approved based on the screening of their applications, will be exempted from paying the full or half amount of the entrance fee or will be allowed to defer payment of the entrance fee, and will be exempted from paying the full or half of the tuition fee.

Applicants who meet both the academic and household criteria will be selected within the University's budget in order from those with the highest level of household financial need.

The academic criteria for the entrance and tuition fee exemption requires that the applicant's entrance examination result should be in the top half at the graduate school to which the applicant belongs, or that the applicant's academic performance record should be in the top half at the undergraduate/graduate school to which the applicant has belonged. The academic criteria for the entrance fee postponement requires that the applicant should have passed the entrance examination of the graduate school to which the applicant belongs.

The entrance/tuition fee exemption will not be granted to those who do not meet the academic criteria above, even if they are in a situation of high household financial need.

The new system of financial aid for higher education is only available to undergraduate students, and there is no tuition fee exemption for graduate students under the new system. Therefore, please note that even if you were granted an entrance/tuition fee exemption as an undergraduate student under the new system or the university's own exemption system, it does not necessarily mean that you will also be granted an entrance/tuition fee exemption for graduate school.

Students from households that are unable to pay the entrance and tuition fees due to the death of their financial provider or the damage to the student or their financial provider caused by a natural disaster within one year prior to enrollment will be exempted from paying the entrance fee and full or half of the tuition fee if their application for exemption is approved. (In the case of a half tuition exemption, the payment of the entrance fee can be postponed for a certain period.)

## **17. How to Apply for the International House (Accommodation)**

Successful international applicants who wish to live in the Kumamoto University International House should apply as below. The period of residence is up to half a year in principle. Unsuccessful applicants cannot live in the International House.

The Graduate School of Health Sciences offers evening classes, classes at specific times or periods, and intensive courses for students who are enrolled as working adults in accordance with Article 14 of the Standards for the Establishment of Graduate Schools. Those who wish to apply for these arrangements should make a request at the time of prior consultation.

### 19. Long-term Enrollment System

The Graduate School of Health Sciences may permit students who have a job or are in the situations described below to systematically complete a course of study for a certain period of time beyond the standard term of study. Students who wish to do so must apply at the time of enrollment.

(1) Eligibility

Students who are working adults, who are engaged in childcare, nursing care, etc., or who are deemed appropriate for the system by the Graduate School of Health Sciences.

(2) Period of long-term enrollment:

The extension period is limited to two years. Therefore, the total period of study should be three or four years.

(3) How to apply:

Application forms for the long-term enrollment system will be distributed to those who wish to use the system at the time of enrollment procedure. Please submit the form by the designated deadline.

(4) Tuition:

The total amount of tuition to be paid by those enrolled for three or four years through this system is the same as for those enrolled for the standard completion period (two years) and is allocated and paid in each year.

### 20. Important Notes

- (1) Once the application documents have been received, no changes can be made to the content of the documents, nor can the entrance examination fee or application materials be returned.
- (2) Those who have made false statements in their applications will be disqualified from taking the examination, and their admission may be revoked if found out later.
- (3) Be sure to bring your Admission Ticket with you when you take the examination. The Admission Ticket will be also required for various procedures related to enrollment, so do not lose it after passing the entrance examination.
- (4) Applicants with physical disabilities who wish to receive special consideration for taking the examination and studying after enrolled should contact the **Student Affairs Office of the Graduate School of Health Sciences**, Kumamoto University by November 14 (Thu), 2024.
- (5) No private vehicles are allowed to enter or park on the university campus.

## Personal Information

Applicants' personal information obtained by Kumamoto University through the selection process will be used for the purposes below, in addition to the use in the selection process:

- (1) Names, etc. of successful applicants will be used in operations related to enrollment process.
- (2) Names, etc. of enrollees will be used in operations related to enrollment process including student register management.
- (3) Names, addresses, etc. of enrollees and tuition fee payers will be used in operations related to payment management including collection of tuitions.
- (4) Personal information including academic records obtained in the selection of applicants will be used in operations related to financial support for students such as selection of entrance fee/tuition waiver and scholarship recipients.
- (5) Personal information such as academic records obtained in the selection of applicants will be used for surveys and research related to the selection of applicants.
